
Summary Measures and Graphs

Category of Change: Payroll Taxes (including maximum taxable)

Proposed Provision: E3.10. Beginning in 2030, apply 2 percent payroll tax rate on earnings over the wageindexed equivalent of \$300,000 in 2017 (about \$497,400 in 2030), with the threshold wage-indexed after 2030. Provide proportional benefit credit for additional earnings taxed, based on the payroll tax rate applied to the additional earnings divided by the full 12.4 percent payroll tax rate.
